1. Roqad Identity Graph Solution

Roqad provides a comprehensive view of all IDs associated with individuals and households, thereby empowering marketers for targeting, analytics and attribution projects.

2. Roqad Data Onboarding – LINK

LINK is a deterministic data onboarding service, where Roqad can translate client Hashed Email Addresses (HEMs) into Mobile advertising IDs (MAIDs), Cookies and IP addresses in large volumes in the US and EU and vice versa. Data onboarding strengthens and activates customer databases (offline or CRM data). Roqad takes that customer offline data online and makes the most of it in the digital environment. In order to make this “merging” possible, there has to be a match between the specific user’s profile and their online activity. Data onboarding provides such a match and enables you to see customers online.
